Mohave Community College ~ Request for Special Admission

For students under 18 years of age.

Special Admission to Mohave Community College may be granted to any person under the age of 18 who meets one of the following classifications. Exceptions require a Division Vice President's approval. The final decision for admission and enrollment to any class will be determined by a Division Vice President. Admission shall be considered on an individual basis and upon written concurrence of the student, parent or guardian, and the college official (Division VP or designee). The college reserves the right to enroll students in courses. Students must renew admittance eligibility each semester they wish to be enrolled in the Special Admission Program.

1. Test Score Achievement

- a. ACT (American College Test) composite of 22 or more or
- b. SAT (Scholastic Aptitude Test) composite (verbal and math) of 930 or more

or

2. "Special Admission" May be granted to a student who:

- a. is 16 years of age or a high school Junior/Senior and has met the established requirements for the courses for which he/she plans to enroll based on the college assessment examination (ASSET) or
- b. is under 16 years of age and has been granted special permission by a Division Vice President based on unofficial school transcript, letter from student stating reason for enrollment request, and any other documentation requested by a Division Vice President, or
- c. is a participant in a special program sponsored by the college.

NOTE: A student may enroll for up to seven credit hours. Students in the Special Admission program are expected to be fully acquainted with and comply with all current published college policies, rules, and regulations. The student consents to have course and grade information released to the appropriate high school officials.

Required Admission Documents:

All students requesting Special Admission to Mohave Community College must submit the following documents:

- Admission/Readmission Form
- Unofficial school transcript (category "2.b" above)
- Letter from the student stating reason(s) for enrollment (category "2.b" above)

Students qualifying for the Test Score Achievement classification must **also** provide:

- Copy of ACT or SAT test scores (category "1" above)
