4.3 Have you filed an Arizona income tax return with the Department of Revenue during the previous tax year?

- A) If you initially enroll as a full-time student, these rates are in effect as long as you continue to take classes on a full-time basis.
- B) If you initially enroll as a part-time student, and keep that status, your in-state residency will take effect the semester immediately following your in-state residency (one-year) date.
- C) If you initially enroll as a full-time student, and change to part-time in a subsequent semester, these rates will be in effect after you have completed two consecutive semesters of part-time enrollment.

I understand that it is my responsibility to inform registration that my residency status should be changed due to B or C listed above. Failure to do so will result in my being charged a higher tuition rate, without refund.
