Admission to Mohave Community College may be granted to any person under age eighteen who meets the established requirements of the courses for which they enroll, that include, at a minimum, student completion of course prerequisites. The individual must submit an on-line Admission form and meet admissions criteria as outlined in ARS 15-1805.01

A community college in this state shall grant admission to any student who is under eighteen years of age and who achieves at least one of the following:

- (a) A composite score of 720 or more on the PSAT.
- (b) A composite score of 720 or more on the SAT.
- (c) A composite score of twelve or more on the ACT.
- (d) A passing score on the relevant portions of the statewide assessment.
- (e) The completion of a college placement method designated by the community college district that indicates the student is at the appropriate college level for the course.
- (f) Is a graduate of a private or public high school or has a high school certificate of equivalency.

I give permission for my minor child to enroll as a student at Mohave Community College (MCC). I understand that this permission, once given, may not be revoked during their academic career at MCC.
