



GED Information

There are five timed sections in the GED exam:

- Reasoning Through Language Arts: 150 minutes
- Mathematical Reasoning: 115 minutes
- Science: 90 minutes
- Social Studies: 70 minutes
- Arizona Civics Exam: 92 minutes

The fee for the GED exam is \$35 per section, except for the Civics section which is \$9, (\$149 total) payable at the time of online registration at www.ged.com.

Each of the sections, except for Civics, requires a minimum test score of 145 to pass. The Civics section requires 60 out of 100 questions correct to pass.

You will receive two discounted retakes for every GED test subject you purchase but don't pass. You have 365 days after your full price test to use these retakes. After receiving two retakes at the reduced price, the price of the test subject returns to the regular price. If you do not pass that subject again, you will receive two more retakes at the reduced rate. GED Testing Service waives its \$20 testing fee, however additional testing fees may still apply in your state.

GED exam applicants' responsibilities:

1. Register for the GED at www.ged.com. When scheduling please keep in mind that you may need to schedule one subject at a time to allow the time span to fit within the Testing Centers' schedule.
2. If you are 16 or 17 years of age, before you can register for an exam at www.ged.com you must bring all of the following to an Academic Advisor:
 - A withdrawal statement from the last school attended
 - A notarized statement (See your local Academic Advisor for the proper document.) from your parent or legal guardian giving you permission to take the GED exam.
 - A valid Photo ID
3. At the time of your test, you are required to have a valid photo identification with you. Acceptable forms of photo ID are: a current driver's license, state-issued ID card, valid passport, military ID, or other forms of government-issued ID

(foreign, domestic, tribal). Questions about acceptable I.D. should be directed to the Testing Center Staff.

GED Test Accommodations:

The GED Testing Program provides accommodations to candidates who have disabilities and is committed to compliance with the requirements of the Americans with Disabilities Act (ADA). Accommodations are made for candidates who have diagnosed physical, mental, sensory or learning disabilities and can provide appropriate documentation from a qualified professional of their impairment and its effect on their ability to take the GED Tests under standard conditions.
